Course overview

This workshop focuses on the different ways of understanding time and how our interpretation of time influences our research. The idea is 1. for the participant to think about how they currently apply time in their work, for then to 2. Learn about debates and perspectives on time, and 3. To rethink their research through the lens of time. The course will address selected debates about time in organizational research, and we will discuss how views of time may challenge how organizational are interpreted. The course is divided into five different themes about time in organizational research, as follows:

Theme 1: Experiencing time from within

Theme 2: Temporal structures

Theme 3: Pasts and futures

Theme 4: Time as resource

Theme 5: Studying time in time

The learning methods will include introductory lectures by Professor Tor Hernes, discussions based on readings, and presentations by the participants. It is important to study the readings before as participants will be asked to discuss these readings during the workshop.

It is expected that the students prepare a 1-2-page summary/reflection on the role of time in their research/thesis, which is submitted at least a week before the start of the workshop.
